

# How Did the Fund Perform Last Year?

Big Data Refiners ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the FactSet Big Data Refiners Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. While the Fund's holdings had strong positive performance, the absence of the "Magnificent 7" stocks drove modest underperformance relative to the Nasdaq-100° and the S&P 500 Technology Sector. For the year ended May 31, 2024, the Fund had a total return of 25.35%. For the same period, the Index had a total return of 26.39% and a volatility of 24.73%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
